Performance "Assuming No Surrender" does not reflect the deduction of Surrender Charge(s) (SC). If reflected, the performance would be reduced. Performance "Assuming Surrender" reflects the maximum SC. The maximum SC for each withdrawal is 7%, declining to 1% by the 9th policy year after the initial premium payment, with no charge thereafter. Withdrawals and surrenders may be taxable transactions, and prior to 59½, may be subject to a 10% IRS penalty (the penalty tax is increased to 25% in the case of a distribution from a SIMPLE IRA within the first two years of your participation in a SIMPLE IRA plan).
