The maximum SC for each payment is 6%, declining to 4% by the 6th year after that premium payment has been in the policy, with no charge thereafter. Withdrawals and surrenders may be taxable transactions, and prior to 59½, may be subject to a 10% IRS penalty (the penalty tax is increased to 25% in the case of a distribution from a SIMPLE IRA within the first two years of your participation in the SIMPLE IRA plan). The Investment Divisions offered through the New York Life Variable Annuity and described herein are different from mutual funds that may have similar names but are available directly to the public.
