Run just one illustration to find out!

Pick a universal or whole life product.

Input the Insured age/rating.

Input the coverage, solving for death benefit or premium if desired.

Under Reports, check the "Multi-Product Comparison."

Then click on:

You've just run all products with just one run!

This internal use only comparison also has a summary of IRR's and commission estimates at the bottom - see examples at right.

Tip #4 Quickly batch run Multiple Insureds!

Do you need a number of scenarios? Create the first illustration, then click Add for each life.

Select New Inforce Case, and input the policy or group number. It will load the inforce data within seconds.		
You may then edit the premiums, illustrate distributions, as needed.		

Troubleshooting

A large Internal Use Only / Not Available for Sale watermark stamp is appearing on the output pages. Why? If the watermark stamp appears on the output, it is an indication that the system detected an invalid illustration and perhaps changed one of your inputs.

1. Look at the top of the Input Messages page (last pages of the printout). It should display a message that indicates what the problem is, such as the death benefit was below the minimum allowed.

2. Is the agent information complete? For non-variable products, a valid illustration requires the agent's name, address and phone number, and for California, the agent's insurance license number. For variable products, the Broker-Dealer information must be provided.

3. Desktop Only - If the state is not an approved valid state for that product, the Input Messages will note the product is not valid for the time period. (The Web will not allow you to pick non-available products.)

4. Desktop Only -- Did you deselect an output page before printing? This feature allows the user to save paper during the analysis process, but the entire presentation must print for the client.

We try to make the error messages easily understood as to what changed. If you are unable to find the source of the problem, e-mail us the saved input or PDF of the output; we'll see if we can identify the problem, and/or run the illustration for you.
